C23-30 FOR THE 2023 PAVEMENT MAINTENANCE** 4 AND REPAIR PROJECT (CIP NO. 21000) AND AUTHORIZING STAFF 5 TO FILE THE NOTICE OF COMPLETION 6 7 WHEREAS, the City of Albany maintains 30 miles of public streets and roadways, 8 with an overall pavement condition index (PCI) of 58 as calculated by the Metropolitan 9 Transportation Commission (MTC) in February 2024; and 10 11 WHEREAS, on November 16, 2020, the City Council adopted Resolution No. 2020-12 108 for the FY19/20-23/24 Capital Improvement Plan (CIP) and appropriated budget for the 13 first three fiscal years of the program; and 14 15 WHEREAS, the Annual Street Rehabilitation Program (CIP No. 21000) is included in 16 the CIP, and reflects the City's commitment to ongoing investment into improving and 17 maintaining City street conditions, including the Citywide PCI, on an annual basis; and 18 19 WHEREAS, on July 17, 2023, the City Council approved Resolution No. 2023-55, 20 awarding construction of the 2023 Pavement Maintenance and Repair Project (Contract No. 21 C23-30) to Dryco Construction, Inc. in the not-to-exceed amount of \$1,120,362.06 and 22 increasing budget appropriations for the Annual Street Rehabilitation Program (CIP No. 23 21000) from Alameda County Transportation Commission (Alameda CTC) Measure BB and 24 VRF (Vehicle Registration Fees) funds as well as local Measure F Street & Strom Drain Tax 25 revenues; and 26 27 WHEREAS, Contract Change Order #1 to Contract No. C23-30 includes additional 28 pavement, curb, and gutter repairs as well as final quantity adjustments in the amount of 29 \$22,736.04, resulting in a final contract amount of \$1,143,098.10; and

WHEREAS, the project is now complete and a Notice of Completion is required to be filed with the County Recorder's Office.

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby
authorizes the City Manager to execute Contract Change Order #1 to Contract No. C23-30,
accept the improvements completed in Contract No. C23-30, and file the Notice of Completion
with the Alameda County Recorder's Office.
