

RESOLUTION NO. 2025-11

A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CALL FOR BIDS FOR THE 2025 BUCHANAN STREET REPAIR PROJECT (CONTRACT NO. C25-05) AS PART OF THE ANNUAL STREET REHABILITATION PROGRAM (CIP NO. 21000)

WHEREAS, the City of Albany maintains approximately 30 centerline miles of public streets and roadways; and

WHEREAS, the Annual Street Rehabilitation Program (CIP No. 21000) is included in the City's Capital Improvement Plan (CIP), and reflects the City's commitment to ongoing investment into improving and maintaining City street conditions; and

WHEREAS, best practices dictate that comprehensive pavement rehabilitation is supplemented by a robust pavement maintenance and repair program to improve street conditions and lengthen pavement remaining service life; and

WHEREAS, Buchanan Street serves as an important arterial connection within and through Albany and sections are in need of repair due to heavy traffic loading; and

WHEREAS, the Project consists of milling and replacement of approximately 2,700 square yards of pavement failure on Buchanan Street between Pierce Street and San Pablo Avenue and restoration and refresh of the traffic striping and pavement markings on the street; and

WHEREAS, a section of Eastshore Highway between Buchanan Street and the intersection entrance to the commercial shopping center is worn and in need of pavement repairs; and

1	WHEREAS, the addition of pavement repair at Eastshore Highway may take advantage
2	of cost and production efficiency of the nearby paving repair at Buchanan Street; and

4	WHEREAS, on November 16, 2020, the City Council adopted Resolution No. 2020-
5	108 adopting the City's five year Capital Improvement Plan and appropriated budget for the
6	first three fiscal years of the CIP, with further budget adjustments made to the Annual Streets
7	Rehabilitation Program as per Resolution Nos. 2023-26, 2023-55 and 2024-49; and

9	WHEREAS, the Project is determined to be categorically exempt under CEQA
10	(California Environmental Quality Act).

12	NOW, THEREFORE, BE IT RESOLVED, that that the Albany City Council
13	authorize the City Manager to approve a Call for Bids for construction of the 2025 Buchanan
14	Street Repair Project (Contract No. C25-05), which will utilize funds previously appropriated
15	under the Annual Street Rehabilitation Program (CIP No. 21000).
