**SUMMARY**

California Government Code § 7072 requires on an annual basis the police department to provide City Council and the public, a report outlining how the military equipment was used, to ensure the police department is adhering to department policy and annually seek renewal of the City’s ordinance regarding this equipment.

**STAFF RECOMMENDATION**

That the Council:

1. Accept this annual military equipment report;
2. Review and renew Ordinance No 2022-02.

**BACKGROUND**

AB 481 was enacted to increase transparency, accountability, and oversight surrounding the use and acquisition of military equipment by state and local law enforcement.

AB 481 requires the Police Department submit an annual military equipment report to the governing body regarding the use of the equipment, any complaints received, any internal audits or other information about violations of the military equipment use policy (“Policy”), the cost of such use, and other similar information as stated in the summary.

A complete list of all military equipment possessed by the City can be found in the Military Equipment List attached to the Military Equipment Use Policy, which is attached to this staff report.

**SUMMARY OF USE OF MILITARY EQUIPMENT AND PURPOSE**

There were no operational uses of any of the Albany Police Department owned and approved military equipment during the 2023 - 2024 period.

On September 21, 2023, the Albany Police Department had a critical incident occur within City limits. The Albany Police Department, with the assistance of the Alameda County Sheriff’s Office investigated a double homicide. The Alameda County Sheriff’s Office utilized

a mobile command center and UAV (unmanned aerial vehicle)/drone to assist with the investigation.

On December 31, 2023, the Albany Police department responded to a what was later determined to be a swatting call (hoax report of an emergency to create a large emergency response) on Jackson St. With assistance from the Berkeley Police Department, an armored rescue vehicle was provided to aid in the safe evacuation of the residents and deployment of officers.

### **SUMMARY OF COMPLAINTS RECEIVED**

No complaints were received.

### **RESULTS OF INTERNAL AUDITS, ANY INFORMATION ABOUT VIOLATIONS OF THE MILITARY USE POLICY, AND ANY ACTIONS TAKEN IN RESPONSE**

An internal audit was performed on 2/29/2024. All inventory was inspected, found to be operational, and accounted for. There were no violations and no actions needed.

### **INTENT TO ACQUIRE NEW EQUIPMENT**

The Albany Police Department recently used distraction devices (a device that rapidly releases light and sound to distract) as part of training and will be purchasing 12 reload device charges at a total cost of approximately \$600. The Albany Police Department is requesting approval of this purchase.

### **TOTAL COST OF EQUIPMENT FOR THE PAST YEAR**

Approximately \$2,800.00 was spent on training with the less-lethal 40- mm and 37-mm launchers, less-lethal shotguns, and distraction devices. For 2024-2025 period, the police department will utilize funds from the general police budget to pay for any costs related to the use of any military equipment.

### **PUBLIC MEETING**

On May 9, 2024, the Albany Police Department will hold a publicized community meeting, at which the public will have the ability to discuss and ask questions regarding this report and the department's funding, acquisition, or use of military equipment.

### **PUBLISHING OF REPORT**

The Albany Police Department will make this annual military equipment report publicly available on its website once accepted by the Council.

**ORDINANCE NO. 2022-02**

**AN ORDINANCE OF THE ALBANY CITY COUNCIL ADOPTING A  
MILITARY EQUIPMENT USE POLICY PURSUANT TO ASSEMBLY BILL 481**

**WHEREAS**, on September 30, 2021, Governor Newsom signed Assembly Bill 481 (“AB 481”) into law which requires law enforcement agencies to adopt a military equipment use policy (“Policy”) prior to taking certain actions relating to the funding, acquisition, or use of military equipment as defined by the law; and

**WHEREAS**, AB 481 requires adoption of the Policy by the City Council before the law enforcement agency can take action to request military equipment as defined by the statute; seek funds (such as grants or in-kind donations) for acquiring military equipment; actually acquire military equipment, either permanently or temporarily by owning, borrowing, or leasing; collaborate with other law enforcement agencies to deploy or use military equipment in the agency’s territorial jurisdiction; use new or existing military equipment in a manner not previously subject to AB 481’s scope; solicit or respond to a proposal for, or enter into an agreement with, any person or entity to seek funds for, apply for, acquire, use, or collaborate in using military equipment; or to acquire military equipment through any other means not specifically detailed in the statute; and

**WHEREAS**, to continue to use military equipment acquired prior to January 1, 2022, the law enforcement agency must commence the process of adopting the Policy no later than May 1, 2022; and

**WHEREAS**, in accordance with AB 481, the proposed Policy was made available on the website of the Albany Police Department (“Police Department”) at least 30 days prior to the public hearing by the City Council to adopt the Policy; and

1           **WHEREAS**, once adopted, the Policy will be made publicly available on the Police  
2 Department's website for as long as the covered military equipment is available for use;  
3 and  
4

5           **WHEREAS**, in accordance with AB 481, the Policy is being agendized as an open  
6 session item at a regular meeting of the City Council, and public comment on the item will  
7 be allowed in accordance with the Brown Act; and  
8

9           **WHEREAS**, this Ordinance shall be reviewed by the City Council at least annually,  
10 and based on an annual military equipment report that will be submitted to the City Council  
11 pursuant to AB 481, the City Council shall determine whether each type of military  
12 equipment identified in the report has complied with the standards for continued approval.  
13

14           **THE COUNCIL OF THE CITY OF ALBANY DOES ORDAIN AS FOLLOWS:**

15           **SECTION 1: INCORPORATION OF RECITALS.**

16           The City Council hereby finds that all of the foregoing recitals are true and correct  
17 and are hereby incorporated and adopted as findings of the City Council as if fully set forth  
18 herein.  
19  
20  
21

22           **SECTION 2. FINDINGS.**

23           Pursuant to Government Code section 7071(d)(1), as may be amended or  
24 renumbered from time to time, the City Council hereby makes the following findings in  
25 support of its adoption of the Policy:  
26

27           A.     The military equipment identified in the Policy is necessary because there is  
28 no reasonable alternative that can achieve the same objective of officer and civilian safety.

1           B.     The proposed Policy will safeguard the public’s welfare, safety, civil rights,  
2 and civil liberties.  
3

4           C.     If the Police Department purchases military equipment pursuant to the  
5 Policy, the equipment is reasonably cost effective compared to available alternatives that  
6 can achieve the same objective of officer and civilian safety.  
7

8           D.     Prior military equipment use complied with the military equipment use  
9 policy that was in effect at the time, or if prior uses did not comply with the accompanying  
10 military equipment use policy, corrective action has been taken to remedy nonconforming  
11 uses and ensure future compliance.  
12

13  
14 **SECTION 3. SEVERABILITY.**

15           In light of the findings in Section 2, and in accordance with AB 481, the Policy  
16 attached to this Ordinance as Exhibit “A” is hereby adopted by the City Council.  
17

18  
19 **SECTION 4. CEQA.**

20           The City Council finds that this Ordinance is not subject to the California  
21 Environmental Quality Act (CEQA) pursuant to Sections 15060(c)(2) (the activity will not  
22 result in a direct or reasonably foreseeable indirect physical change in the environment) and  
23 15060(c)(3) (the activity is not a project as defined in Section 15378) of the CEQA  
24 Guidelines, California Code of Regulations, Title 14, Chapter 3, because it has no potential  
25 for resulting in physical change to the environment, directly or indirectly.

**SECTION 5. SEVERABILITY.**

If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications, and to this end, the provisions of this Ordinance are declared to be severable.

**SECTION 3: PUBLICATION AND EFFECTIVE DATE.**

This Ordinance shall be posted at three public places within the City of Albany and shall become effective thirty (30) days after the date of its posting.

# Military Equipment

## 705.1 PURPOSE AND SCOPE

State MODIFIED

The purpose of this policy ("Policy") is to provide guidelines for the approval, acquisition, and reporting requirements of military equipment pursuant to Assembly Bill 481 ("AB 481") (California Government Code § 7070 .).

### 705.1.1 DEFINITIONS

State MODIFIED

Definitions related to this Policy include those provided in Government Code section 7070, and as follows:

**Governing body** – City of Albany City Council ("City Council").

**Military equipment** – Includes but is not limited to the following:

- Unmanned, remotely piloted, powered aerial or ground vehicles.
- Mine-resistant ambush-protected ("MRAP") vehicles or armored personnel carriers.
- High mobility multipurpose wheeled vehicles ("HMMWV"), two-and-one-half-ton trucks, five-ton trucks, or wheeled vehicles that have a breaching or entry apparatus attached.
- Tracked armored vehicles that provide ballistic protection to their occupants.
- Command and control vehicles that are either built or modified to facilitate the operational control and direction of public safety units.
- Weaponized aircraft, vessels, or vehicles of any kind.
- Battering rams, slugs, and breaching apparatuses that are explosive in nature. This does not include a handheld, one-person ram.
- Firearms and ammunition of .50 caliber or greater, excluding standard-issue shotguns and standard-issue shotgun ammunition.
- Specialized firearms and ammunition of less than .50 caliber, including firearms and accessories identified as assault weapons in Penal Code section 30510 and Penal Code section 30515, with the exception of standard-issue handguns.
- Any firearm or firearm accessory that is designed to launch explosive projectiles.
- Noise-flash diversionary devices and explosive breaching tools.
- Munitions containing tear gas or OC, excluding standard, service-issued handheld pepper spray.
- TASER® Shockwave, microwave weapons, water cannons, and long-range acoustic devices ("LRADs").
- Kinetic energy weapons and munitions.

- Any other equipment as determined by City Council or a state agency to require additional oversight

### 705.2 POLICY

State MODIFIED

It is the Policy of the Albany Police Department ("Department") that members of this department comply with the provisions of AB 481 with respect to funding, acquisition and use of military equipment.

### 705.3 MILITARY EQUIPMENT COORDINATOR

Best Practice MODIFIED

The Chief of Police shall designate a member of the Department to act as the military equipment coordinator. The responsibilities of the military equipment coordinator include but are not limited to:

- (a) Acting as liaison to the City Council for matters related to the requirements of this Policy.
- (b) Identifying Department equipment that qualifies as military equipment in the current possession of the Department, or the equipment the Department intends to acquire that requires approval by the City Council.
- (c) Conducting an inventory of all military equipment at least annually.
- (d) Collaborating with any allied agency that may use military equipment within the jurisdiction of the Department.
- (e) Preparing for, scheduling, and coordinating the annual community engagement meeting to include:
  1. Publicizing the details of the meeting; and
  2. Preparing for public questions regarding the Department's funding, acquisition, and use of military equipment.
- (f) Preparing the annual military equipment report for submission to the Chief of Police and ensuring that the report is made available on the Department website.
- (g) Establishing the procedure for a person to register a complaint or concern, or how that person may submit a question about the use of a type of military equipment, and how the Department will respond in a timely manner.

### 705.4 MILITARY EQUIPMENT INVENTORY

State MODIFIED

The list of qualifying military equipment for the Department is attached to this Policy as Exhibit "A" and incorporated into the Policy by this reference.

### 705.5 APPROVAL

State MODIFIED

The Chief of Police or the authorized designee shall obtain approval from City Council by way of an ordinance adopting the Policy. As part of the approval process, the Chief of Police or the

authorized designee shall ensure the proposed Policy is submitted to City Council and is available on the Department website at least thirty (30) days prior to any public hearing concerning the Policy. The Policy must be approved by City Council prior to engaging in any of the following:

- (a) Requesting military equipment made available pursuant to 10 USC § 2576(a).
- (b) Seeking funds for military equipment, including but not limited to applying for a grant, soliciting or accepting private, local, state, or federal funds, in-kind donations, or other donations or transfers.
- (c) Acquiring military equipment either permanently or temporarily, including by borrowing or leasing.
- (d) Collaborating with another law enforcement agency in the deployment or other use of military equipment within the jurisdiction of this Department.
- (e) Using any new or existing military equipment for a purpose, in a manner, or by a person not previously approved by City Council.
- (f) Soliciting or responding to a proposal for, or entering into an agreement with, any other person or entity to seek funds for, apply to receive, acquire, use, or collaborate in the use of military equipment.
- (g) Acquiring military equipment through any means not provided above.

### **705.6 COORDINATION WITH OTHER JURISDICTIONS**

State **MODIFIED**

Military equipment used by any member of this Department shall be approved for use in accordance with this Policy. Military equipment used by other jurisdictions that are providing mutual aid to the City of Albany, or otherwise engaged in law enforcement operations in the City, shall comply with their respective military equipment use policies in rendering mutual aid or carrying out a law enforcement function related to a criminal matter under their investigation.

### **705.7 ANNUAL REPORT**

State **MODIFIED**

Upon approval of this Policy, the Chief of Police or the authorized designee should submit a military equipment report to City Council for each type of military equipment approved within one year of approval, and annually thereafter for as long as the military equipment is available for use.

The Chief of Police or the authorized designee should also make each annual military equipment report publicly available on the Department website for as long as the military equipment is available for use. The report shall include all information required by Government Code section 7072 for the preceding calendar year for each type of military equipment in department inventory. "Type" of military equipment is defined to mean "each item that shares the same manufacturer model number."

### **705.8 COMMUNITY ENGAGEMENT**

State **MODIFIED**

Within thirty (30) days of submitting and publicly releasing the annual report, the Department shall hold at least one well-publicized and conveniently located community engagement meeting, at which the Department should discuss the report and respond to public questions regarding the funding, acquisition, or use of military equipment.

### **705.9 COMPLAINT PROCESS**

<b>Equipment Capabilities:</b> The 40mm Less Lethal Launcher is capable of firing 40mm less lethal Kinetic Energy Munitions.  The 37mm Less Lethal Launcher is capable of firing 37mm less lethal Kinetic Energy Munitions.

<b>Quantity Owned:</b> 5 – Defense Technology Low Roll Distraction Device 5 – Defense Technology Distraction Device No. 25	<b>Lifespan:</b> Until Used
<b>Equipment Capabilities:</b> Distraction devices are ideal for distracting dangerous suspects during assaults, hostage rescue, room entry, or other high-risk arrest situations. The device produces atmospheric over-pressure and brilliant white light and, as a result, can cause short-term (6-8 seconds) physiological/psychological sensory deprivation to give officers a tactical advantage.

<b>Training Required:</b> Officers authorized to use this device must complete a POST-certified distraction device course as required by POST and policy.

<b>Manufacturer Product Description:</b> Unavailable.	
<b>Purpose/Authorized Uses:</b> UAS/Drones may be utilized to enhance the Department's mission of protecting lives and property when other means and resources are not available or are less effective. Uses may include but are not limited to: search and rescue; suspect apprehension; crime scene	
<b>Fiscal Impacts:</b> None. Equipment owned, maintained, and operated by another agency.	
<b>Legal/Procedural Rules Governing Use:</b> Use is established under FAA Regulation 14 CFR Part 107, and outside agency UAS policy.
